There are no early detection tests, no effective long-term treatments and, unless the cancer is surgically removed in its earliest stages, **NO CURE**. Please join Calvin and CJJRF as we raise awareness and funds for pancreatic cancer and the Foundation quality initiatives.

On November 10, 2017, CJJRF will partner with One Talent, Inc. to host **“Jazzing Purple in ATL”** (Atlanta, GA).
